DWR "Subsidence Mitigation Funding Agreement"— The Board will receive an update on this agreement to build several hundred acres of wetland in the western and central portion of the island in an effort to reverse subsidence, sequester carbon and reduce greenhouse gases. The update will include a discussion on moving a drainage ditch adjacent to the Sherman Island Cross Road, the repair or replacement of several risers, the repair of several siphons, and the need for a topographic survey of the Whale's Mouth and Whale's Belly projects.
