1. Roll Call of Board Members and Staff

3. District Manager’s Report – The Board will hear an update from the District Manager on current District activities.
  - a) Capital Improvements – The manager will discuss needed improvements to equipment, canals, ditches, pumps, and siphons.

4. Review of Minutes of Prior Meetings – The Board will review and consider the approval of the prior meeting(s).
5. Accounts Payable – The Board will review and consider the approval of accounts payable and transfers. A general financial update will also be provided.
6. Board to hear an update on Assessment No. 28.
7. New Assessment - Prop 218 – Board to consider hiring an engineer to develop a new District-wide assessment.
8. Irrigation Canal – Board to discuss the current condition of the canal. The Board will hear an update on the cleaning and determine if additional work is necessary.
9. Outrigger Marina Fire Cleanup – Board to receive an update on the fire at the Outrigger Marina and the cleanup coordination with the State Lands Commission and Sacramento County.
10. PG&E Birds Landing – Board to receive an update on tower demolition and consider going to bid for a standby barge.
11. Mutual Aid Agreement – The Board will consider executing a mutual aid agreement with the River Delta Fire Department and Reclamation District 1601.
12. Encroachment Permit No 2021-3 (Adgate Addition) – Board to discuss status and possibly release retention.
13. Encroachment Permit No. 2022-4 (PG&E D-1262 Gas Transmission Dig) – Board to hear an update and discuss this PG&E project.
14. Encroachment Permit No. 2023-5 (PG&E Idle Line Removal) – Board to hear an update and discuss this PG&E project.
15. Encroachment Permit No. 2024-6 (Caltrans Highway 160 Repaving) – Board to hear an update and discuss and the repaving of Highway 160 from Station 878+00 – 990+00.
16. Mayberry Slough Setback Levee Habitat – Board to discuss and possibly act on trimming vegetation encroaching on the level patrol road. The Board may approve an indemnity agreement with the Yolo County RCD.
17. DWR “Subsidence Mitigation Funding Agreement” (expiration date is 12/31/2030) – The Board will consider approving a proposal for a “carbon offset” verification of this project. The Board will also receive an update on this agreement to build several hundred acres of wetland in the western and central portion of the island in an effort to reverse subsidence, sequester carbon and reduce greenhouse gases. The update will include a discussion and possible action on the following items:

- 18. Public Entity Agreement #4600015864 with DWR (Highway 160 Emergency Waterside Repair) – The Board will receive an update on this agreement that will reimburse the District for the emergency repairs to the levee adjacent to Highway 160.
- 19. Public Entity Agreement with DWR (Sherman Lake Rock Slope Protection) - The Board will receive an update on this agreement that will reimburse the District for levee maintenance along Sherman Lake. The Board will review the agreement to pay for rock slope protection along the Sherman Lake levee. The Board may approve the agreement and declare the maintenance work exempt from CEQA.
- 20. Project Funding Agreement SH-17-1.1-SP (SJR Setback Levee Project, Station 175+00 to 199+00) – The Board will hear a status update on this project. Expiration Date 06/30/2027.
- 21. Project Funding Agreement SH-24-1.0 SP (SJR Multi-Benefit Project, Station 330+00 – 368+00) – The Board to hear a status update on this project. Expiration 12/31/2026.
- 22. Engineer's Report – The Board will hear an update from the engineers regarding District activities not included as agenda items.
