3. District Manager’s Report – The Board will hear an update from the District Manager on current District activities.
 - a) Capital Improvements – The manager will discuss needed improvements to equipment, canals, ditches, pumps, and siphons.
4. Review of Minutes of Prior Meetings – The Board will review and consider the approval of the prior meeting(s).

5. Accounts Payable – The Board will review and consider the approval of accounts payable and transfers. A general financial update will also be provided.
6. Board to hear an update on Assessment No. 28.
7. New Assessment - Prop 218 – Board to receive an update regarding a new District-wide assessment.
8. Board to consider approving engagement letter from Croce, Sanguinetti & Vander Veen, Inc. to prepare the annual independent audit and special districts financial transaction report for the year ended June 30, 2024.
9. Outrigger Marina Fire Cleanup – Board to receive an update on the fire at the Outrigger Marina and the cleanup coordination with the State Lands Commission and Sacramento County.
10. PG&E Birds Landing – Board to receive an update on tower demolition and the possibility of taking ownership of aggregate base material from PG&E. Board to review bids and consider awarding a contract for a standby barge.
11. Sherman Island Cross Road – The Board will discuss the need for ditch work and repairs adjacent to this road.
12. Pump No. 1 Repair/Replacement – Board to review quotes for repair or replacement of Pump No. 1.
13. Pump No. 3 Canal Cleaning – Board to review quote and consider authorizing cleaning of the canal from Whale’s Mouth to Sherman Island Cross Road.
14. Encroachment Permit No. 2022-4 (PG&E D-1262 Gas Transmission Dig) – Board to hear an update and discuss this PG&E project.
15. Encroachment Permit No. 2023-5 (PG&E Idle Line Removal) – Board to hear an update and discuss this PG&E project.
16. Encroachment Permit No. 2024-3 (Renwick Siphon Repair) – Board to hear an update on the status of the siphon repair.
17. Encroachment Permit No. 2024-6 (Caltrans Highway 160 Repaving) – Board to hear an update and discuss and the repaving of Highway 160 from Station 878+00 – 990+00.
18. Encroachment Permit No 2024-7 (Vasquez Levee Access Ramp Gates) – Board to review application for installation of gates and consider issuing an Encroachment Permit.
19. Campos Dumping – Board to discuss grindings dumped on Campos property and recent import of fill material. The Board may choose to impose fines against Campos for violating his encroachment permit.
20. DWR “Subsidence Mitigation Funding Agreement” (expiration date is 12/31/2030) –The Board will receive an update on this agreement to build several hundred acres of wetland in the western

and central portion of the island in an effort to reverse subsidence, sequester carbon and reduce greenhouse gases. The Board will consider approving an updated master services agreement for a “carbon offset” verification for the project. The update will include a discussion and possible action on the following items:

- a. Whale’s Belly
 - i. Warranty Work
 - ii. Remediation Work
 - iii. Recirculation Pump
- b. Whale’s Mouth
 - i. Perimeter Ditch PG&E Crossing
 - ii. Siphon No. 1 Fish Screen
 - iii. Siphon No. 2 Replacement
 - iv. Maintenance Agreement -The Board will consider the expiration of the current contract.

- 21. Public Entity Agreement with DWR (Sherman Lake Rock Slope Protection) - The Board will receive an update on this agreement that will reimburse the District for levee maintenance along Sherman Lake.
- 22. Project Funding Agreement SH-17-1.1-SP (SJR Setback Levee Project, Station 175+00 to 199+00) – The Board will hear a status update on this project. Expiration Date 06/30/2027.
- 23. Project Funding Agreement SH-24-1.0 SP (SJR Multi-Benefit Project, Station 330+00 – 368+00) – The Board to hear a status update on this project. Expiration 12/31/2026.
- 24. Engineer’s Report – The Board will hear an update from the engineers regarding District activities not included as agenda items.
- 25. Superintendent’s Report – The Board will hear an update from the Superintendent on current District activities.
