- 7. Assessment Call No. 27 The Board to discuss upcoming assessment call no. 27.
- 8. Board to discuss and possibly approve engagement letter from Butterfield + Co., CPAs, Inc. to perform ongoing accounting services for July 1, 2023 June 30, 2024.
- 9. Board to consider the approval of job descriptions for each of its employees and adding them to the employee manual.
- 10. Board to hear a status update on engaging in a relationship with a new insurance carrier.
- 11. Encroachment Permit No. 2022-01 (Adgate Addition) Board to hear an update and discuss this project.
- 12. Encroachment Permit No. 2022-4 (PG&E D-1262 Gas Transmission Dig) Board to hear an update and discuss this PG&E project. The Board will discuss progress on the cleaning of a ditch over a pipeline.
- 13. Encroachment Permit No. 2022-6 (Caltrans Highway 160 Mitigation Site) Board to discuss this Caltrans project.
- 14. Encroachment Permit No. 2023-1 (Campos Levee Access Ramp) Board to consider issuing an encroachment permit and issuing a fine.
- 15. Outrigger Marina Board to discuss current condition of the Outrigger Marina and possibly act on an unpermitted dock landing.
- 16. Highway 160 Turnout Barriers Board to discuss placing barriers at the Highway turnout from Station 925+00 928+00 to prevent illegal camping and dumping.
- 17. Drainage Plan The Board will receive an update and consider adopting the Drainage Plan.
- 18. DWR Fence Relocation Board to consider authorization to relocate a cattle fence along the Pump No. 3 Canal.
- 19. Irrigation Crossing Board to discuss issues with trash at the Pump/Canal No. 3 irrigation crossing.
- 20. Pump No. 1 Discharge Pipe Replacement Board to consider approval of welding existing steel pipe for future installation.

- 21. Pump No. 3 Rehabilitation The Board will receive a status update on this project and possibly approve the repair of the trash rack and pump station. The Board will review the complete repair plan and cost.
- 22. Project Funding Agreement SH 10-2.12 Highway 160 Construction Work /Sacramento River Repair Project Agreement to add a drainage system to the portion of the levee experiencing seepage problems along the Sacramento River at Stations 870+00 through 940+00. The Board will hear a status update on this project. Project Funding Agreement expiration date 12/31/2023.
- 23. DWR "Subsidence Mitigation Funding Agreement" (expiration date is 12/31/2024)— The Board will receive an update on this agreement to build several hundred acres of wetland in the western and central portion of the island in an effort to reverse subsidence, sequester carbon and reduce greenhouse gases. The update will include a discussion and possible action on:
 - a. Moving a drainage ditch adjacent to the Sherman Island Cross Road, the repair or replacement of several risers, the repair of several siphons, and the need for a topographic survey of the Whale's Mouth and Whale's Belly projects.
 - b. Authorizing the District Engineer and General Manager to assess and direct repairs to the Whale's Mouth perimeter berm cutoff trench.
 - c. Maintenance necessary for the Whale's Belly project and putting the maintenance contract out to bid.
 - d. A salinity plan that will coordinate wetland operations with District operations.
 - e. A contract between the District and Hydrofocus to perform a subsidence study.
- 24. Project Funding Agreement SH-17-1.0-SP (Phase I of San Joaquin River Setback Levee/Habitat Bench Multi-Benefit Project, Stations 175+00 to 199+00) The Board will hear a status update on this project. Expiration Date 06/30/2027.
- 25. 2023 Projects Solicitation Package for Multi-Benefit Projects The Board will hear an update on its Concept Proposal and consider adopting a resolution authorizing a Full Application.
- 26. Board to discuss and possibly approve its annual CEQA exemption for routine levee maintenance.
- 27. Engineer's Report The Board will hear an update from the engineers regarding District activities not included as agenda items.
- 28. Superintendent's Report The Board will hear an update from the Superintendent on current District activities.
